### **ACTION ALERT!**

No Action Alert this week. We are not calling on the Governor to veto any bills this year.

Here's to hoping against hope that the Council on Environmental Quality follows suit by choosing the No Action Alternative in their new rule-making to "streamline and modernize" (aka gut) the National Environmental Policy Act.

With this space available, just spreading the good news that Great Basin Water Network, White Pine County and their many friends and allies had another huge win in Nevada District Court against SNWA, the Nevada State

Engineer and the Las Vegas Water Grab. It looks increasingly unlikely that the massive, destructive and expensive scheme to drain rural groundwater for real estate development can survive this latest legal setback.

## **News of Week Seven (Week # 7)**

SB 250, bill that would have eased the path for permit-ting of the Promontory Point landfill to receive solid and hazardous wastes, was tabled in committee in a big win for Great Salt Lake advocates. Failures of HB 133 and HJR 21 were also wins for Team GSL, though not HB 296. The Senate revived and passed a 3<sup>rd</sup> Substitute of HB 233, creating the Natural Resources Legacy Fund, without the depleted uranium funding source. Key water bills we supported fared well this year, as most were well vetted in advance. Water banking, split season leasing, and several technical bills addressing long-standing, thorny issues were resolved. HB 328 and HCR 22 addressing Colorado River system development were an exception, though neither have much teeth.

Inland Port Bills (HB 347, SB 112) passed as expected. SB 92, which would have financed a comprehensive, statewide rail transit and heavy rail plan died due to its cost. No climate change bills (SCR 12, HCR 11, & HB 465) passed. Mining bills SB 131 and HB 296

passed, as did oil and gas bills HB 129 and SB 148, though SB 41 failed. A final insult was the failure to recognize the 50<sup>th</sup> anniversary of Earth Day April 22.

## **Budget News**

The appropriations acts included all of the funding for conservation-related programs listed in last week's Budget News. In addition, the final budget action, HB 3 - the "bill of bills", included funding for HBs 27, 39, 197, 255, 278, SBs 26 and 148, and HJRs 3 and 15.

The results on air quality-related bills and budgets were a bit disappointing, given the lofty goal of \$100 m. in new AQ investments at the start of the Session. The final total was \$9,800,000 which includes the previously reported \$5 m. for electric vehicle research and recharging infrastructure projects, and \$200,000 for Uintah Basin ozone research. New appropriations include \$1.6 m. for increasing Front Runner train service, \$2 m. for carbon capture efforts, and \$50,000 for energy efficiency (HB 235). The sales tax exemption for Tier 3 gasoline production was extended for 18 months, though that was a mixed-bag result.

Lastly, of critical interest to all, the Legislature put up \$19 m. for coronavirus emergency response, with \$16 m. going to the Division of Finance, \$2 m. for local health departments, and \$1 m. for meals programs for seniors and for testing and in-home services. They also authorized \$4.

To be draw from the Disaster Recovery Restricted Account. Another \$6 m. in federal funds are expected.

## What's Ahead

Most new laws will be signed by the Governor between now and April 1, and will go into effect on May 12. Interim Committees will begin meeting in May. We expect that, as in past years, committee meetings will be held on the 3<sup>rd</sup>
